The offenses listed below do not require a court appearance if you have not had two other moving violations within the last twelve (12) months. You may pay the stated amount in person at our office, by mailing a money order or cashier's check made payable to the Celina Municipal Court, or by credit card online. Online payments are assessed an additional fee. **Please sign the back of your ticket** and return it along with your payment (not needed if paying online). If you wish a receipt or the officer kept your license, please enclose a self-addressed stamped envelope. If the box for financial responsibility is marked "no", bring proof of liability insurance for the date on your traffic violation. This proof may be a form or letter from your agent, indicating your name, the vehicle you were driving, and the dates of coverage.
