The offenses listed below do not require a court appearance if you have not had two other moving violations within the last twelve (12) months. You may pay the stated amount any of the following ways: in person at our office with cash, cashier's check, money order, or credit card; mail a money order or cashier's check made payable to the Celina Municipal Court; online or by phone using a credit card. Online payments are assessed an additional fee. Please sign the back of your ticket and return it along with your payment (not needed if paying online or over the phone). If you wish a receipt or the officer kept your license, please enclose a self-addressed stamped envelope. If the box for financial responsibility is marked "no", bring proof of liability insurance for the date on your traffic violation. This proof may be a form or letter from your agent, indicating your name, the vehicle you were driving, and the dates of coverage.

FAILURE TO APPEAR OR PAY THE FINE WILL SUBJECT YOU TO ARREST AND/OR CANCELLATION OF YOUR OPERATOR'S LICENSE.

PAYMENT IS DUE ON OR BEFORE YOUR COURT DATE.
